Friday May 29th Open starting at 9:00 a.m. Judges, bird planters, and gun team on site at 8:00 a.m. Puppy stake to follow second series of Open

Saturday May 31st Open starts at 9:00 a.m. MSFTC Futurity event after second series of Open.

Sunday June 1st Amateur stake begins at 9:00 a.m. Puppy stake will follow second series of Amateur.

SITE: The trial will be held at the Hussey Well Field in North Conway, NH. This is the site where we held last year's trial. It has fallow fields with broken cover, tree rows, and ample room to run a challenging and varied three day trial, not to mention the background scenic vistas of Mt. Washington and the White Mountains.

HEADQUARTERS: We are fortunate again this year; the headquarters for the trial will be the 1785 Inn and Restaurant which is adjacent to the Hussey property. The Inn has 17 available rooms. Dogs are welcome. A

magnificent breakfast is included in the room cost, and the restaurant will be open during the trials - also the site of the banquet.
