### Motels to Area 21

#### **From Best Western Tumwater Inn to Ft. Lewis Area 21:**

- ✈ Go right on Capitol Blvd
- ✈ Go 1 mile and turn right on Custer Way
- ✈ Go 2 blks. and turn right on Cleveland Ave which will change name to Yelm Hwy SE
- ✈ Go 3 miles and turn right on Rainier Road
- ✈ Go 7 ½ miles and turn left on “pothole road” – a sign/flag will mark
- ✈ Stay on “pothole road” and watch for more signs/flags

#### **From Yelm Prairie Motel to Area 21:**

- ✈ Turn right on Yelm Avenue (Hwy 507)
- ✈ Go ½ mile and turn left at light to stay on Hwy 507
- ✈ Go apprx. 6 miles and turn right on Minnesota St (just past Rainier Market)
- ✈ Go 2.8 miles and turn right on “pothole road” – a sign/flag will mark
- ✈ Stay on “pothole road” and watch for more signs/flags
