- ✓ **Only flat collars are allowed on the test grounds.**

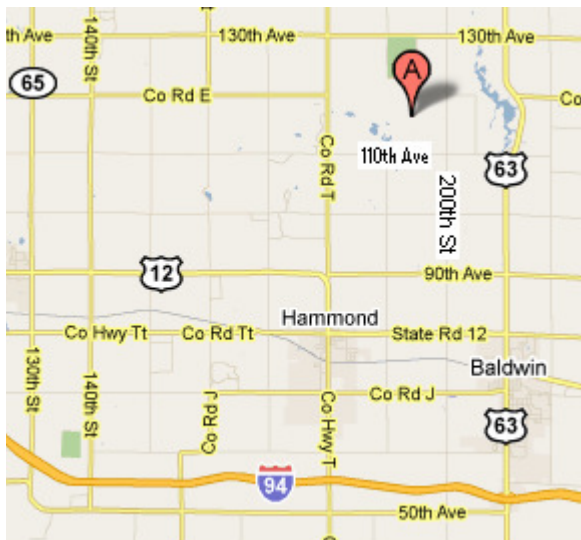

- Entry fees will not be refunded in the event a dog is absent, disqualified, excused by a judge or barred from the test by action of the hunt test committee.
- Entry fees will be refunded minus a \$5.00 handling charge per day for bitches in season or dogs injured after the closing date if a veterinarian certificate is presented to the hunt test secretary.
- No entry fee will be refunded if the test cannot be opened or completed by reason of riots, civil disturbance, an act of god, public emergency, act of a public enemy, or any other cause beyond the control of the committee.
