*The Patriot Sporting Spaniel Club and the AKC require an item of blaze orange clothing to be worn by marshals, bird planters, handlers, gunners and Judges. A cap by itself is not sufficient to meet this requirement.
Severe training, correcting or disciplining of any dog will not be allowed on the grounds.*

Additional Requirements

PSSC requires all handlers to report to the line with drinking water for their dogs.

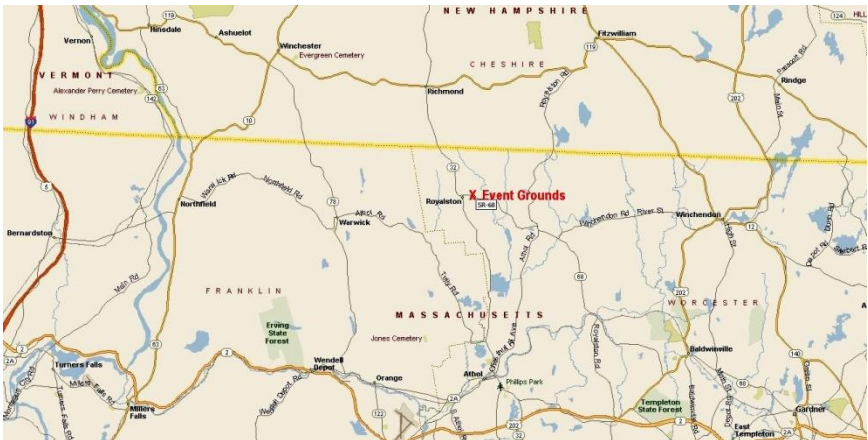
Directions to the Event Grounds

From the West on Rte 2. At exit 17, take ramp right for RT-32 toward Athol / Petersham. Turn left onto RT-32 / Petersham Rd. Drive approx. 1.1 miles. Turn left onto RT-2A / RT-32 / Main St. Drive approx. 1.4 miles. Then follow Chestnut Hill Ave. directions.

From the East on Rte 2. At exit 18, take ramp right for RT-2A toward Athol. Turn left onto RT-2A. Drive approx. 2.6 miles. Then follow Chestnut Hill Ave. directions.

Chestnut Hill Ave. directions. Turn right onto RT-32 / Chestnut Hill Ave. Turn left to stay on RT-32 / Crescent St. Turn right to stay on RT-32 / Silver Lake St. Silver Lake St. eventually becomes RT-32/Athol-Richmond Rd. RT-32 merges with Route 68 just north of the main entrance to Hedgerow Kennel and Hunt Club. Take Route 68 East approximately $\frac{1}{4}$ of a mile. The entrance to the grounds is on the right.

From Keene, NH – Take Route 12 South and turn right onto Route 32 South. Continue on Route 32 into MA. Turn left onto Route 68 East. Follow Route 68 approximately $\frac{1}{4}$ of a mile. The entrance to the grounds is on the right.
