Directions

For those of you with a GPS, the location for the water test is on the property of Rick Ahearn: that is 867 New County Rd., Biddeford, ME 04005.

New County Road is Rt. 5 and the Ahearn property is just east of the intersection of Rt. 5 and Rt 35. The entrance to the property will be marked – the entrance is the driveway of the Ahearn home.

If you are coming by way of I-95, get off at the Old Orchard Beach exit (I-195). Stay to the right and get off the first exit. Turn left at the light, the turn right at the next light (North St.). Take the first left on Garfield St. which will take you to Rt. 5 -- turn right. It is approximately 6 or 7miles to Rick Ahearn's property. You'll go over the Turnpike, a small stream, River Rd., Gordan Rd., Gould Rd. and then ----- you are there!!

If you come to Rt. 35, turn around and go back, you missed it!!
